THE PERSISTENT TRAILS WE SEE TODAY CANNOT BE NORMAL VAPOUR TRAILS

The persistent trails (and most likely the non-persistent trails) we are seeing are most definitely NOT normal 'contrails' or 'vapour trails'. The disinformation leaflet (Aircraft contrails factsheet2) written by the American EPA is full of technical inaccuracies and contradictions.

These are the reasons why the persistent trails (and virtually all non-persistent trails) we see today are **not** normal vapour trails:-

Normal aircraft vapour trails can only form at -57°C:

The US EPA leaflet fails to inform the reader that normal aircraft vapour trails require extremely low temperatures (- 57° C), low pressure and high humidity (above 65% - one source says 100%). This extreme temperature is only achieved at very high altitude – 35,000 to 37,000 feet and above. Ice particles do not form at lower altitudes, hence the reason why only the high altitude cirrus clouds are composed of ice particles.

It is even suggested that the RH must be 100%³

Dew Point and Relative Humidity

Dew point is the temperature at which water vapor in any static or moving air column will condense into water. In other words, the air is saturated and can no longer hold the moisture at this temperature. When the air temperature drops below its dew point, excess moisture will be released in the form of condensation. Condensation problems are most likely to occur in climates where temperatures frequently dip to 35°F or colder over an extended period of time.

Relative humidity is a percentage measurement of the amount of water vapor present in the air in relation to the amount it is capable of holding at that temperature. For example, 50% relative humidity indicates the air is carrying one-half of the maximum amount of moisture that it is capable of containing at the given temperature. There is a relationship between the dew point and relative humidity. A high relative humidity means that the dew point is near the current air temperature. Therefore, a relative humidity of 100% indicates that the dew point is equal to the current temperature. This relationship between dew point and relative humidity is given in Table C-1.

Persistent trails in South Africa (and across the world) are seen at all different altitudes and in all weather conditions :

We have documented sightings of trails as low as 22,000 feet through to 26,000 feet and 28,000 feet. Sightings occur across the whole of South Africa where Relative

Humidity varies widely in the upper Troposphere. Trails are seen when the relative humidity is as low as 3%. Trails are seen in all weathers, on odd days and with zero consistency that would uphold the 'normal' contrail theory.

High Bypass Turbofan Jet Engines emit mostly carbon soot, not water vapour :

The modern Turbofan jet engine is fitted on virtually all modern commercial and military aircraft and is virtually incapable of producing any type of vapour trail, whether persistent or non-persistent⁴. The older engines which could produce contrails under certain conditions were no longer in use in the majority of commercial aircraft by the early 1980s.



Trails from aircraft with no flight details

Using <u>www.Flightradar24.com</u> we most often see aircraft with either no flight details at all or a flight with no destination. Most flights seen spraying in the Western Cape appear to originate from Cape Town. Flights often 'disappear' off the radar. Some aircraft seen spraying are not shown on the radar. <u>See Appendix D for examples.</u>

Circular trails, criss-cross trails, weird 'contrails'

Why Aluminium Causes Trails That Start Metres From The Engine

"The melting point of Aluminum is 660 deg C. while the combustion chamber in a 747 engine is over 1,800 deg C. This combination would cause any aluminum in the fuel supply to vaporize on combustion and for a while longer as it exits the engine exhaust as thrust. The vaporized aluminum remains transparent until it mixes with oxygen to allow the aluminum vapor to transform into its final stage as a metallic powder aerosol of aluminum oxide. Observers are understandably confused when the temporary "invisibility" of the aluminum vapor somewhat mimics the appearance of a normal contrail. When the contrail of aluminum oxide continues for miles the agents of disinformation will incorrectly claim that it's a "persistent contrail" of water vapor. The problem with this devious explanation is that Contrail science requires that very high relative humidity must prevail where the aircraft is flying. But the relative humidity of the upper atmosphere above 32,000 feet rarely exceeds 60% which is far too low for persistent contrail formation." ⁵



Geoengineering reduces photons hitting the earth which reduces precipitation

The spraying of metal particulates in the atmosphere reduces the ability of natural sunlight to hit the earth. This decreases the number of photons hitting the earth which decreases precipitation (rainfall). 23

WHAT IS GEOENGINEERING?

Geoengineering is the illegal program of weather modification via stratospheric aerosol injection (SAI or SAG). Aircraft spray particulates into the upper atmosphere to create different weather patterns which include:-

- 1. Drying up existing clouds to remove precipitation (rainfall) from one area and relocating it to another.
- 2. Preventing the build-up of precipitating clouds to create areas of drought.
- 3. Seeding clouds to create rainfall.
- 4. The use of EMF technology, known as atmospheric heaters (e.g. HAARP High Frequency Active Aurora Research Project),

Spraying is usually conducted ahead of low pressure fronts/cold fronts which would normally bring rainfall but due to the injection of stratospheric aerosols and the combination of atmospheric heaters, this prevents precipitation. Droughts are an expected consequence of this geoengineering.

Continuous spraying is seen across South Africa (and the rest of the world) to maintain low precipitation and to move precipitation to targeted areas. The scientific papers which reference 'geoengineering' state that atmospheric spraying is intended to reflect the sun's rays back in to the upper atmosphere to help prevent the earth from getting warmer. This is known as "Solar Radiation Management".





IONOSPHERIC HEATERS (HAARP)²⁹

Ionospheric heaters work in conjunction with stratospheric aerosol injection as follows:-

- 1. Aircraft spray heavy metals principally aluminium and barium into the atmosphere ³⁰ along with many other toxic compounds.
- 2. Aluminium is 'hydrophyllic' meaning that water is attracted to it.
- 3. The ionospheric heater uses ELF (extreme low frequency) electromagnetic radiation (3 to 30 Hz) to transmit energy into the sprayed area.
- 4. The ELF ionises the particles and pushes them including the water vapour into the atmosphere and away from the sprayed area. Watch this video to see how pulsed water vapour rises as a result of the ELF³¹
- 5. The result of the ionisation dries up the clouds and water vapour and prevents precipitation.
- 6. This is why, after witnessing the spraying and the resultant freaky clouds, the sky will then clear. Your rain has now been stolen and taken elsewhere. The result? Drought in one area and the potential for floods in another.

What is an Ionospheric Heater?

Essentially it is a giant, steerable antenna that aims millions of watts of ELF waves into one tiny patch of the atmosphere. To compare, the largest legal radio station in North America emits 50,000 watts. The HAARP system (High Frequency Active Auroral Research Project) emits 3.6 <u>million</u> watts. HAARP was founded in 1992 in Alaska by the US Air Force, Navy and a number of academic institutions. It went online in 1994 and completed further construction in 2007. It has now been superseded by many other ionospheric and atmospheric heaters³².

The official stated purpose of an ionospheric heater is to study the properties and behaviour of the ionosphere for civilian and defence purposes.

However, the intense energy that HAARP emits into the atmosphere actually **heats up** the atmosphere causing weather changes and is being used for weather modification purposes³³:


deliberate and how much is from pollution is probably a debate that could go on forever. Until geoengineering is stopped in its entirety we will never know.



Re-routing the Jet Stream³⁹

"As far back as 1958, the chief White House advisor on weather modification, Captain Howard T. Orville, said the U.S. defense department was studying "ways to manipulate the charges of the earth and sky and so affect the weather" by using an electronic beam to ionize or de-ionize the atmosphere over a given area.

The seminal 1996 Air Force report 'Owning the Weather 2025' outlines a weather modification program utilizing ground based support such as HAARP.

Let us reference a passage from Nick Begich and Jeane Manning's book "Angels Don't Play this HAARP":

"Eastlund's enthusiasm for planetary-scale engineering came through just as clearly in an interview with Omni Magazine. While acknowledging that many of the uses of his invention are warlike, he also talked about 'more benign' uses. His view of benign included using the technology to reroute the highaltitude jet stream, which is a major player in shaping global weather. Another way to control the weather with his technology would be to build 'plumes of atmospheric particles to act as a lens or focusing device' for sunlight, he told Omni. With this, the people controlling the antennae could aim in such a way that the return beams would hit a certain part of the earth. With the heating ability, they could experiment until they could control wind patterns in a specific place.

The Omni article explained. 'What this means, he says, is that by controlling local weather patterns one could, say, bring rain to Ethiopia or alter the summer storm pattern in the Caribbean.'

United States patent #4,686,605⁴⁰ 'Method and Apparatus for Altering a Region in the Earth's Atmosphere, Ionosphere and/or Magnetosphere' is one of the 12 HAARP patents. Dr. Eastlund is credited as the inventor. It states, "Weather modification is possible by, for example, altering upper atmosphere wind patterns or altering solar absorption patterns by constructing one or more plumes of atmospheric particles which will act as a lens or focusing device."

A summary of HAARP's intended purposes⁴¹

"In a nutshell, we can see that HAARP is intended to do the following:

- Destroy, deflect, or confuse missiles or aircraft
- Modify the weather
- Change the molecular composition of an atmospheric region, by increasing or decreasing ozone, nitrogen, carbon dioxide, carbon monoxide, and/or nitrous oxides
- Increase the drag on a missile or satellite
- Focus vast amounts of sunlight on selected portions of the earth.



"GWEN (Ground Wave Emergency Network) transmitters placed 200 miles apart across the USA allow specific frequencies to be tailored to the geomagnetic-field strength in each area, allowing the magnetic field to be altered. They operate in the LF range, with transmissions between LF 150 and 175 KHz. They also emit waves from the upper VHF to the lower UHF range of 225 – 400 MHz. The LF signals travel by waves that hug the ground rather than radiating into the atmosphere. Risk of extreme weather events⁴⁵

Based on the study, a benefit of geoengineering — in addition to reducing global average surface temperatures — could come into play with extreme precipitation events. Such events present the risk of flooding, as was seen recently in Colorado when a 1-in-1,000 year rainfall event led to extensive flooding.

In a world with more CO2, precipitation extremes are becoming more severe and more common. According to the National Climate Assessment, released in draft form in January, the most extreme precipitation events have increased in every region of the contiguous U.S. since 1950, a trend that the study attributed partly to increased evaporation from manmade global warming. At the same time, a more intense water cycle is likely to lead to more frequent and severe drought in other areas, such as in the Southwestern U.S.

The U.N. concludes that although SRM may possibly slow the loss of Arctic sea ice, but not without "unacceptable climatic impacts elsewhere." One particular method of SRM involves injecting aerosols into the atmosphere via airplanes. The study found that the use of sulphur aerosols for SRM would be associated with a risk of stratospheric ozone loss. There is also a risk that stratospheric aerosol injection (SAI) would have a small impact on climate change but could lead to negative impacts on biodiversity.

The diet contained adequate levels of Ca, Mg, P and Vit.D3. Growth, food intake, behaviour and mortality were measured, extensive haematology and clinical biochemistry carried out, organ weights determined, X-ray photographs of the bones taken and complete histopathological examination was performed. In addition Sr-content of blood, bone and muscles was determined. Thyroid weights were significantly increased in the males of the 1200 and 4800 ppm group. Histological evidence for increased thyroid activity was noticed in the males of the 4800 ppm group. Pituitary weights were significantly decreased in the females of the 300 ppm and 4800 ppm group, but not of the 1200 ppm group. A histologically confirmed glycogen depletion of the liver was noted biochemically in the highest dose group (4800 ppm). Sr-content in bone was increased at all dose levels having a constant level from 4 weeks onwards, thus indicating that a no effect level cannot be established. If the increased Sr-concentration in the bone can be considered a non-toxic effect, the non-toxic effect level appears to be 309 ppm.

J Marvin Herndon is a geophysicst and nuclear chemist. He has published a paper entitled:

Evidence of Coal-Fly-Ash Toxic Chemical Geoengineering in the Troposphere: Consequences for Public Health⁵⁰

Abstract: The widespread, intentional and increasingly frequent chemical emplacement in the troposphere has gone unidentified and unremarked in the scientific literature for years. The author presents evidence that toxic coal combustion fly ash is the most likely aerosolized particulate sprayed by tanker-jets for geoengineering, weather-modification and climate-modification purposes and describes some of the multifold consequences on public health. Two methods are employed: (1) Comparison of 8 elements analyzed in rainwater, leached from

The results show: (1) the assemblage of elements in rainwater and in the corresponding experimental leachate are essentially identical. At a 99% confidence interval, they have identical means (T-test) and identical variances (F-test); and (2) the assemblage of elements in the HEPA dust and in the corresponding average un-leached coal fly ash are likewise essentially identical. The consequences on public health are profound, including exposure to a variety of toxic heavy metals, radioactive elements, and neurologically-implicated chemically mobile aluminum released by body moisture in situ after inhalation or through transdermal induction.

In essence, this highly toxic by-product of the coal industry is being utilised as an atmospheric aerosol.

Cloud Seeding is Harmful⁶⁵

When studying the efficacy and consequences of cloud seeding experiments, the experimenters tend to be biased in saying cloud seeding with silver iodide enhances precipitation without negative consequences. However, much of the literature substantiates that not only does cloud seeding fail to achieve the desired effect, it also yields harmful consequences. Some of these consequences include rain suppression, flooding, tornadoes, and silver iodide toxicity. (1,2,3)

The harm of rain suppression is obvious to everyone. For farmers and ranchers, this would mean no rain, no gain -- an economic loss. Losses would include poorer crop harvest, lack of range vegetation, and a loss of hunting lease income due to wildlife reduction. This is particularly true for ranches in western Potter County, an area PGCD has called "geographically handicapped." (2) Most ranchers and farmers do not choose to take the gamble on their land and livelihood based on experimentation. (1,2)

Silver iodide is toxic

The harmful effects of silver iodide are insidious.(3) Yet, according to the web site of the PGCD, the effects are so minimized that the following is stated: "The concentration of iodide in iodized salt used on food is far above the concentration found in rainwater from a seeded cloud."(4) In addition, in early December of 2002, at the Amarillo meeting jointly conducted by the Panhandle Groundwater and the North Plains Groundwater Conservation Districts, one representative stated that silver iodide was good for the heart. In a private conversation, another explained that silver miners live longer. Iodized salt may seem benign; however, some states such as Colorado have outlawed the use of salting icy roads.(5) Among harmful effects, salt is toxic to the water and land.(5)

The Office of Environment, Health and Safety, UC Berkeley, rates silver iodide as a Class C, non-soluble, inorganic, hazardous chemical that pollutes water and soil.(8) It has been found to be highly toxic to fish, livestock and humans.(6,7,8,9) Numerous medical articles demonstrate that humans absorb silver iodide through the lungs, nose, skin, and GI tract.(7,8,9) Mild toxicity can cause GI irritation, renal and pulmonary lesions, and mild argyria (blue or black discoloration of the skin). Severe toxicity can result in hemorrhagic gastroenteritis, shock, enlarged heart, severe argyria, and death by respiratory depression.(8)

Moreover, a key manufacturer of silver iodide for weather modification, Deepwater Chemicals, warns of potential health effects of silver iodide in their Material Safety Data Sheet as follows:

Chronic exposure of silver iodide can cause serious disease

Chronic Exposure/Target Organs: Chronic ingestion of iodides may produce "iodism", which may be manifested by skin rash, running nose, headache and irritation of the mucous membranes. Weakness, anemia, loss of weight and general depression may also occur. Chronic inhalation or ingestion may cause argyria characterized by blue-gray discoloration of the eyes, skin and mucous membranes. Chronic skin contact may cause permanent discoloration of the skin.(10)

Under the guidelines of the <u>Clean Water Act</u> by the EPA, silver iodide is considered a hazardous substance, a priority pollutant, and as a toxic pollutant.(10) Some industries have learned this all too well

Cloud Seeding can cause bigger hail stones

"Silver iodide is also used for hail mitigation methods. We believe the media isn't telling us the real science behind Silver iodide "hail suppression" and weather patents. Knowing that Silver iodide cloud-seeding is used for inducing ice-nucleation into the sky, we believe instead of getting small hail pellets in a larger general area of the city, we instead get bigger hail pellets to come down instantaneously (with heavy shorter-duration rain). This would mean affecting a smaller area, but with more severity. 

- 4. A roadmap to achieving weather dominance by 2025






Figure 5-1. A Core Competency Road Map to Weather Modification in 2025.

Bill Hopkins, the executive vice president for the National Weather Service employees organization (NWSEO) said this:

"As a taxpayer, I find it highly disturbing that a government agency continues to push gag orders to hide how they operate. This is the work of the American government, owned by the American public, and should be open to the American public."

Jeff Ruch, the executive director "PEER" (Public Employees for Environmental Responsibility) said this about the "gag orders".

"The National Weather Service is about the last place where national security-style secrecy rules need to be enforced," Ruch noted that the broad scope of the gag orders put much of what goes on inside the agency under wraps. "Everyone is free to talk about the weather except for the people working inside the National Weather Service. Go figure."

Space Weather Modification

It is also important to note the attention placed on "Space Weather Modification". This is something we are going to be seeing more activity on and this also requires investigation and oversight, together with public inclusion and consultation. It is noted that South Africa now has a Space Weather program in operation:

"The space weather products and services are required primarily for communication and navigation systems, in the defence, aeronautics, navigation and communication sectors."

Apparently we have just hosted a 'Multinational Space Weather Project⁷¹' (South Africa, UK and USA) on 15 April 2016. It is a pilot study of global space weather application. 'Pilot' = 'guinea pigs'. What part does this play in the dramatic increase of aerosol spraying that has been sighted all across South Africa, and, in particular, Mossel Bay?

Reading between the lines, this project is to enhance space weather applications under adverse conditions, ie: to enhance performance of power grids, high frequency radio communication, GPS, satellites, avionics, aircraft navigation and

communication systems, when space weather is not conducive. Could 'enhance' mean to 'increase the conductivity of the ionosphere' with geoengineering techniques i.e. aerosol spraying by aircraft?

'Space weather' refers to conditions on the sun that influence the performance and reliability of space-borne and ground based technological systems.

Another application: this site also says that they are putting up MAGNETOTELLURICS (MT) stations in various locations in South Africa. This is an electromagnetic geophysical method of imaging the Earth's subsurface. The commercial uses include hydro carbon (oil and gas) exploration, geothermal exploration, mining exploration and hydrocarbon and groundwater monitoring.

They also have a project called 'PLASMON Project' (partnered 8 countries) to investigate the plasmasphere - an area 1500kms above the earth's surface, using distributed ground networks.

Financial – Food Control, Monsanto

Small farms and farmers are being devastated by the deliberate reduction of precipitation through the geoengineering programs. Stratospheric aerosol injection (SAI) is drying up precipitation and preventing natural rainfall. The natural corollary of this nefarious action is to allow the massive corporate entities to take over the supply and production of huge commercial crops, including the dangerous GMO crops.

Aluminium is a key component of SAI and now Monsanto has created a crop that is "aluminium resistant" 72 73 74.

The devastating droughts in major crop producing areas in South Africa will have farreaching consequences on the price of staple foods, resulting in greater poverty and deprivation. For the first time, South Africa will have to <u>import</u> vital staple foods at great cost.

An example of the possible consequences of weather modification techniques is massive hailstorms, as seen recently in Bloemfontein. This needs to be thoroughly investigated, especially considering weather modification aircraft were seen in the vicinity prior to this hailstorm.

Approaching People on the topic of Geoengineering

First of all, semantics are extremely important in regard to the introduction of geoengineering. The geoengineering term is related to hard science, the "chemtrails" term has no such verifiable basis but rather leads anyone that Googles the term straight to "conspiracy theory" and "hoax" definitions. Use the terms "climate engineering" and "geoengineering".

- 1. Spend some time researching the climate engineering/geoengineering issue.
- 2. You don't have to be an authority, but you should know and be able to explain the basics. Stick to those "BASICS". Wondering off track and into "RABBIT HOLES' does not help build credibility with the geoengineering issue. It is never helpful to go into a long "rant" when trying to introduce the subject of geoengineering to an uninformed person. Such "rants" only cause defenses to go up. It is generally enough to say: "The government is experimenting with our weather. There are no regulations or oversight for what they are doing, the materials for these programs are highly toxic, we are all breathing in the fallout and the media is not covering this issue."You can then perhaps mention aluminum is a primary element being sprayed and that this fact appears to have a strong connection to the alarming rise in Alzheimer's, autism, ADD, etc.Its important to mention that lab tests of rain all over the globe are showing huge amounts of toxic metals know to be use with climate engineering programs.
- 3. One can also mention the total disruption of weather patterns caused by geoengineering.
- 4. Encourage them to investigate and leave it at that unless the individual shows a strong interest in hearing more

- 6. If asked why these programs are being carried out, Geoengineering appears to have many purposes. If an Alzheimer's group is being approached, point out the lethal levels of aluminium in the spray and the known connection of that metal to the ailment, etc. Targeting appropriate information is important.
- 9. When target mailing individuals or groups on line, use the same principal mentioned above. Sent them a plea to investigate accompanied by articles and data on geoengineering that would most be of interest to the particular recipient.
